ADDING COURSES BEFORE OR DURING THE ADD/DROP PERIOD:

1. Students are responsible for all course content, including material covered before the add date.
2. Students must attend 80% of **all scheduled classes** in the term in order to receive academic credit for a course.
3. Tuition for any added courses will be due no later than the first day of classes or immediately upon receipt of the request to add, whichever is later. If payment is not

received within two weeks of the add date, a late fee will be assessed.

4. Courses may not be added after the end of the second week of the term.

WITHDRAWING FROM A COURSE (Week 3 through Week 9 of Term)

1. A grade of "W" will appear on the student's transcript.
2. Tuition fees for this course will be pro-rated as follows:
 - a. Withdrawal date and refund is based on the week that the student last attended class.
 - b. The student is responsible for any **unpaid** tuition for all class sessions attended.
 - c. Tuition will be refunded for those class sessions held after the student has withdrawn.
